



Liability Waiver

As a condition of a Participant's participation in the Orangeville Public Library's Makerspace, the Participant (or their legal guardian as applicable) must provide the Library with a signed copy of this Liability Waiver.

Acknowledgement of Risk. I understand that participation in the Orangeville Public Library's Makerspace involves the use of tools, equipment, and technologies that may include (but are not limited to) 3D printers, laser cutters, vinyl cutters, sewing machines, button makers, and computer equipment (the "**Equipment**"). I acknowledge that use of the Equipment may involve risks, including the risk of minor or serious personal injury, damage to personal property, or loss of work. I voluntarily assume all risks associated with my participation.

Release of Liability (Including Negligence). I agree that Orangeville Public Library and its Board, and the Corporation of the Town of Orangeville and its Councillors, and the foregoing organizations' respective employees, volunteers, and agents (collectively the "Library Parties") shall not be held liable for any injury, loss, or damage caused by the negligence of the Library Parties or otherwise arising from my participation in the Makerspace or use of the Equipment except where prohibited by law.

Indemnification. I agree to release, indemnify, and hold harmless the Library Parties from any claims, demands, actions, or costs (including legal fees) arising from my use of the Makerspace, or from the use by a minor for whom I am legally responsible.

Responsibility for Equipment and Space. I have read and I understand the [Makerspace Guidelines](#) which I acknowledge having been provided access to and having had an opportunity to review prior to executing this waiver. I agree that I am responsible for the proper use and care of the Makerspace, Equipment, and furnishings during my session. I will remain in the space while using the Equipment. All Equipment must be returned clean and in working condition. I will clean up my workspace after my session. I accept that I will be liable for repair, replacement, or cleaning costs where I have failed to comply with the guidelines or have otherwise caused damage to the Library's property.

Lawful and Appropriate Use. The Makerspace may be used for lawful purposes only. Prohibited uses include the creation of weapons, pornographic or obscene material, illegal items, or content that violates intellectual property rights.

Revocation of Access Rights. I understand that my access and right of participation may be revoked or suspended by the Orangeville Public Library for any reason and at any time, at the Library's sole

discretion. Should I engage in a prohibited use or violate any of the Guidelines, I accept that my right of participation in the Makerspace may immediately be revoked by the Library without prior notice.

Supervision Policy – Children under 14 years of age. Children under the age of 14 must be accompanied by a parent or legal guardian at all times unless participating in staff-led programming.

Term of Waiver. This waiver applies to every access in and to the Makerspace and the Equipment unless and until revoked or replaced by the Library in writing. I accept that the Library may, at any time, require me to sign an updated version of the Liability Waiver or confirmatory copy of the waiver as a condition of my continued participation in the Makerspace.
